TERMS & CONDITIONS:-

2. Tender form along-with BOQ & Standard Bidding Documents for bids at S.No 1,2,3,4,5,6 & 7 can be obtained from the office of Director Works, 1st Floor Administration Block, Private Room No.37 Side A on payment of Rs.1000/- (Non Refundable) per work in BOK KTH, Branch.
3. According to Provincial Government Notification No.KPPRA /M&E/Estt:/1-5/2016 the contractors / bidder who quote their bids / rates more than 10% below the engineers estimate shall submit an additional security in the form of Original call deposit equal to 8% of the Engineer Estimate in the name of Hospital Director MTI, KTH Peshawar. After Satisfactory commencement of work by the successful bidder 8% of Call deposit may be replaced with the bank guarantee of the same amount from schedule bank.
4. The additional security shall be released to the contractor in four installments i.e 25% to be released after completing 25% of the project, 50% to be released upon 50% completion.75% to be released upon 75% completion and the remaining amount to be released after completion of the project.
5. In case the bidder quotes more than 10% below the estimated cost (Engineer's Estimate) and the bid is not accompanied by the additional security then the bid shall be considered as **"Non-Responsive"** and the 2nd lowest bidder and so on will be considered accordingly.
6. The contractors / firms shall quote their rates on **Above / Below System (both in words & Figures) on tender form and BOQ** as all tenders shall be processed according to above / below system on BOQ on market rate.
7. The bidders are required to send their financial bid clearly marked as **"Original"** through courier and duplicate in separate envelopes clearly marked as **"Duplicate"** and then sealed in one Envelope be sent to the Hospital Director MTI, KTH Peshawar by the closing date and time.

8. All prevailing taxes such as Income Tax, Sales Tax and KPRA Tax @specified rate which are increasing / decreasing from time will be deducted from successful bidder.
9. Those contractors who's tender do not accompany original Call Deposit will be considered non responsive.
