

TERM AND CONDITIONS FOR THE SUBMISSION OF TENDERS / QUOTATIONS IN RESPECT OF KHYBER TEACHING HOSPITAL, PESHAWAR FOR YEAR 2017-18 FOR LOCAL PURCHASE OF DRUGS/DISPOSABLE.

The following documents are to be attached with Quotation.

1. Valid Retail Sales License/s.
2. Registration with Income Tax Department, providing the NTN & Sales Tax Registration No. in the name of proprietor.
3. Attested certificates of the qualified person/s running the licensed premises.
4. Attested copies of CNIC of the proprietor & qualified person.
5. Premises will be inspected and evaluated on the basis of an approved check list fulfilling provision of the Drug Act 1976 and rules framed there under read with the NWFP Drug Rules 1982 (Amended 2017).
6. Cold chain maintenance certificate and detail of equipment.
7. Bank Statement of Pharmacy/Medicine Store/Proprietor with Tax return to evaluate the financial competence.
8. Quotations must be submitted on the letter pad of the bidder along with attested copy of valid retail sale license.
9. Separate CDRs @ 2% of the bid amount in the name of Hospital Director, MTI, KTH, for each category.
10. Quotations should reach the undersigned positively on or before the date mentioned in the advertisement through Registered post/Courier service with acknowledgement receipt envelopes marked as quotation for LP/Zakat as separate but same envelope.
11. Hand written quotation and quotation without relevant attested document will not be entertained and will be rejected under rule
12. Bidder of the Pharmacy/medicine Store submitting quotation may choose to attend the opening of quotations on the time and date mentioned in the advertisement.
13. Medicines should be supplied in original commercial packing as per demand chit & substitution without prior approval of End user/In-charge Zakat will not be acceptable.
14. No unregistered drugs shall be supplied, else the firm will be recommended to Govt. for black listing and contract of firm will be cancelled.
15. Risk purchase will be made at risk & cost of contractor by picking the required drugs from the market and recouped by the contractor.
16. Contractor will ensure regular supply even if bills are under process due to unavoidable circumstances.
17. Tax will be applicable /deducted as per Govt. rules.
18. Phone Numbers / Mobile No: of the firm must be mentioned on quotations.
19. The successful bidder will execute a contract on judicial stamp paper of Rs:100/-
20. Rate will be valid for one year i.e till 30-06-2018 and may be extended till finalization of the next tender if not finalized before 30-06-2018.
21. Separate bill (fortnightly) shall be submitted in each head of account else non-payment/delayed payment if so arise shall be taken as liability created by the defaulting LP contractor.
22. Firms having bad past performance will not be considered.
